**Sub : Directions u/s 31 ( A) of Air (Prevention and Control of Pollution) Act, 1981, read with Rule 20 (A) (6) of the Air (Prevention and Control of Pollution)(Union Territories ) Rules, 1983, to Stop Operation of Electricity Generator Sets run on Diesel /Petrol/Kerosene in NCT of Delhi.**

Whereas, Central Pollution Control Board is the State Board for all the Union Territories to exercise powers and perform functions under the Air (Prevention and Control of Pollution) Act, 1981.

And whereas, Central Pollution Control Board has delegated all the powers and functions under the Air (Prevention and Control of Pollution) Act, 1981 in respect of NCT of Delhi to Delhi Pollution Control Committee vide Notification No. S.O. 198(E) dated 15.03.1991.

And whereas, whole of Union Territory of Delhi has been declared as an Air Pollution Control Area vide Notification No. GSR 106(E) Dated 20.02.1987 under sub-section (1) of section 19 of the said Air Act, 1981.

**And whereas, Delhi faces grave air pollution particularly in winter season and level of pollutants like Particulate Matter Concentration (PM<sub>2.5</sub> and PM<sub>10</sub>) goes much beyond the prescribed standards for Ambient Air Quality and operation of Electricity Generator Sets run on Diesel / Petrol / Kerosene has been identified as one of the sources of air pollution in Delhi.**

And whereas, as per section 17(1) (a) of Air Act, 1981, Delhi Pollution Control Committee (DPCC) is to plan a comprehensive program for the prevention, control and abatement of air pollution and to secure execution thereof.

And whereas, Hon'ble National Green Tribunal vide various orders has directed Govt. of NCT of Delhi and DPCC to initiate steps to curb the Fugitive Emissions / Air Pollution in NCT of Delhi.

And whereas, in pursuant to the order dated 02.12.2016 of Hon'ble Supreme Court of India in the matter of M. C. Mehta Vs Union of India & Others regarding air quality, Graded Response Action Plan (GRAP) has been notified by the Ministry of Environment, Forests and Climate Change, Govt. of India on 12.01.2017 for implementation through Environment Pollution (Prevention and Control) Authority for NCR (EPCA).

And whereas, EPCA in its meeting held on 07.10.2019 has decided that in Delhi provisions of very poor and severe category of GRAP will be enforced from 15<sup>th</sup> October, 2019 to 15<sup>th</sup> March, 2020, irrespective of Ambient Air Quality Levels in NCT of Delhi.

And whereas, action w.r.t very poor category of Graded Response Action Plan (GRAP) included "Stop use of Diesel Generator Sets" and EPCA in its meeting held on 07.10.2019 has decided that operation of Electricity Generator Sets run on Diesel / Petrol / Kerosene of all capacities will be banned in NCT of Delhi excluding Electricity Generator Sets used for essential services.

Now therefore, in view of the above & in exercise of the powers conferred under section 31(A) of the Air (Prevention and Control of Pollution) Act, 1981 read with Rule 20(A) of the Air (Prevention and Control of Pollution) (Union Territories) Rules, 1983 and keeping in view to curb high air pollution in Delhi, **Delhi Pollution Control Committee hereby bans the operation of Electricity Generator set(s) run on Diesel / Petrol / Kerosene of all capacities in NCT of Delhi, with immediate effect and up to 15.03.2020 or till further orders, excluding Electricity Generator Sets used for essential services such as:**

- i. Medical Purposes (Hospitals / Nursing Homes/ Health Care Facilities)
- ii. Elevators (Lifts)/ Escalators
- iii. Railway Services / Railway Stations
- iv. Delhi Metro Rail Corporation services including its Trains & Metro Stations
- v. Airport & Inter State Bus Terminus (ISBTs)

**The concerned DMs, Deputy Commissioners of Police, DCs of Municipal Corporations, Secretary of NDMC and CEO Delhi Cantonment Board shall comply with the above mentioned directions and submit daily action taken report to "DPCC" on Email ID: msdpcc@nic.in.**

In case of non-compliance with the above mentioned Directions u/s 31(A) of Air Act, 1981, action as per the provisions contained in Section 37 of the said Air Act, 1981 shall be initiated against the defaulters.

This issues with the approval of the Chairman, Delhi Pollution Control Committee.
