**Sub : Quotation for AMC of Multimedia Projector XD 490 U for the year 2019-2020.**

Sir,

Reference to the above cited subject, quotations are invited for AMC for Multimedia Projector Model XD 490 U for the financial year 2019-2020 (for a period of one year from the date of issue) on the following terms & Conditions:-

1. Complaints should be attended within 24 hrs. This would be apart from regular visits required to maintain the machine in working condition.
2. Contract would only be for Labour charges and charges for spare parts shall be extra. However, Vendor shall be responsible for replacing required parts within stipulated time and deposit the old parts in the office.
3. Failure to timely attendance of complaints or repair the machine would result in cancellation of contract. Further, Department will be at liberty to get the machine repaired from the open market and charge the cost to the vendor.
4. "The goods, including for works contract, shall be supplied by bidder or its authorized distributor in Delhi and against a sale invoice issued from Delhi. The delivery of goods shall also be made from Delhi. The bidder dealer or its authorized distributor, as the case may be, who supplies the goods should be registered with the Delhi VAT Department and carry a valid Tax identification Number issued by it. The bidder shall, however, be responsible for compliance with all conditions, warranties/guarantees, irrespective of the fact that the goods are supplied by him directly or through its authorized distributor. Further, the quoted bid price in the tender shall be inclusive of all taxes and duties".

The pre-authorized agencies shall also ensure the following:-

"Delivery of goods is made from Delhi and against a sale invoice issued from Delhi. The dealer supplying goods should be registered with the Delhi VAT Department and carry a valid Tax Identification Number issued by it."

5. In case of unsatisfactory service the contract shall be terminated at any time by the Competent Authority.
6. PAN/TAN/SERVICE TAX/GST Number of the firm will also be mentioned in quotation.

The said Multimedia Projector Model XD 490 U can be inspected on any working day from 10.00 AM to 5.00 PM, if so desired.

The quotation must reach the undersigned in a sealed cover by **28/06/2019** upto **2.30 PM** and the same will be opened on **28/06/2019** at **3.00 PM**. The quotations received after the due date & time shall not be accepted and no correspondence shall be entertained in this regard. Further, Department reserves the right to accept or reject any/all quotations without assigning any reason and the decision of the Department shall be full & final and binding on you.
